NOTIFICATION

Sub: Modification of the pay structure of the Teachers, Headmasters and officers of Elementary Cadre.

Odisha Elementary Education (Method of Recruitment and Conditions of Service of Teachers and Officers) Rules, 1997 was formulated to regulate the conditions of the service of the Teachers and Officers of Elementary cadre. Subsequently, the said Rules have been amended in the year 2009, 2014 and 2019.

As per the said Rules and its amendments, the cadre includes different posts belonging to different grades such as Level-V(A), Level-V(B), Level-IV, Level-III, Level-II, Level-I bearing different pay scales. The proposal for revision of the pay structure of the Elementary cadre was under active consideration of Government.

Now, Government after careful consideration have been pleased to modify the pay structure of different levels of the cadre as detailed below:

| Sl. No. | Grade of the post in the cadre | Posts belong to the grade | Existing Level of Pay as per ORSP Rules, 2017 | Level of pay after modification |
|----------------|---------------------------------------|--|--|--|
| 1 | Level- V(A) | Assistant Teacher | Level - 6 | No change |
| 2 | Level- V(B) | Senior Teacher | Level - 7 | Level - 8 |
| 3 | Level - IV | Headmaster, Primary School & Graduate Teacher | Level - 8 | Level - 9 |
| 4 | Level - III | Senior Headmaster, Primary School & Headmaster, Upper Primary School | Level - 9 | Level - 10 |
| 5 | Level - II | Assistant Block Education Officer | Level - 9 | Level - 10 |
| 6 | Level - I | Block Education Officer | Level - 10 | Level - 11 |
